The Mexico was the fastest growing country, with a CAGR of 6.4% over the 2017-21 period.
- Within the pasta & noodles industry, the US is the leading country among the NAFTA bloc, with market revenues of \$9,295.2 million in 2021. This was followed by Canada and Mexico, with a value of \$1,126.3 and \$700.1 million, respectively.
- The US is expected to lead the pasta & noodles industry in the NAFTA bloc, with a value of \$10,615.6 million in 2026, followed by Canada and Mexico with expected values of \$1,306.3 and \$917.1 million, respectively.
