- Within the carbonated soft drinks industry, China is the leading country among the top 5 emerging nations, with market revenues of \$26,499.8 million in 2021. This was followed by Mexico and Brazil with a value of \$19,539.1 and \$16,033.9 million, respectively.
- China is expected to lead the carbonated soft drinks industry in the top five emerging nations, with a value of \$35,324.6 million in 2026, followed by India and Mexico with expected values of \$27,568.3 and \$26,365.9 million, respectively.
