The packaged water industry within the NAFTA countries had a total market value of \$43,403.7 million in 2021. The Mexico was the fastest growing country, with a CAGR of 4.5% over the 2017-21 period.
- Within the packaged water industry, the US is the leading country among the NAFTA bloc, with market revenues of \$41,234.8 million in 2021. This was followed by Canada and Mexico, with a value of \$1,986.3 and \$182.6 million, respectively.
- The US is expected to lead the packaged water industry in the NAFTA bloc, with a value of \$53,478.8 million in 2026, followed by Canada and Mexico with expected values of \$2,828.0 and \$233.9 million, respectively.
