**Report description:**

2022 off-trade volume sales of RTDs in Poland persisted in their decline. However, it is noteworthy that the rate of descent was more moderate compared to the previous year. This is likely attributed to the lifting of COVID-19 restrictions and the subsequent reopening of on-trade establishments, which could operate without limits. The sales of RTDs in the on-trade saw a substantial increase, by contrast, though this wasn't enough to halt the overall slump in the category.
