Off-trade wine, which accounts for the majority of sales in Croatia, recorded slight decline in 2022 in volume terms following a strong year in 2021 when sales recovered after the pandemic. Increased demand for more affordable brands was evident in the channel in 2022 due to lower consumer purchasing power. On-trade sales, meanwhile, performed very well, registering double-digit volume growth in 2022 as a result of the recovery of tourism. However, due to strong inflation, on-trade establishment...
