Off-trade wine sales saw a strong decline in volume and value in 2022, largely due to the revival of cross-border trade with Sweden and an increase in international travel in the aftermath of the COVID-19 crisis. The on-trade wine market experienced significant recovery in 2022, but slowed in the last months of the year. This poorer performance in the latter stages of the year can be attributed to a decrease in consumer confidence due to the high rate of inflation and global events.
