The active headrests are typically integrated into the backrest of the front seats and are connected to sensors that detect the severity and direction of a rear-end impact. When a collision is detected, the active headrests respond by moving forward and upward to meet the occupants' heads, thereby reducing the distance between the headrest and the head. This motion helps to support the head and neck, preventing excessive flexion or extension that can cause strain and injury.

The escalating preference for comfort and ergonomics among consumers majorly drives the global market. Since active seat headrests can be adjusted to support the neck and head, promoting a more comfortable seating position, this is creating a
