With high inflation still driving up production costs and unit prices, ice cream in Bulgaria is set to register faster growth in retail current value sales than retail volume sales in 2023. Demand has remained fairly robust despite falling purchasing power, however, with all categories projected to expand in retail volume terms, and overall growth in this respect expected to be slightly faster than in 2022. This is partly because the return to pre-pandemic routines has continued to boost impulse...
