- The South African Bakery & Cereals market had total revenues of \$2,700.0 million in 2022, representing a compound annual growth rate (CAGR) of 4.5% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.1% between 2017 and 2022, to reach a total of 1,188.5 million kilograms in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 6.3% for the five-year period 2022 2027, which is expected to drive the market to a value of \$3,658.4 million by the end of 2027.
