- The Canadian Bakery & Cereals market had total revenues of \$13,483.3 million in 2022, representing a compound annual growth rate (CAGR) of 3.9% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.6% between 2017 and 2022, to reach a total of 2,234.3 million kilograms in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.7% for the five-year period 2022 2027, which is expected to drive the market to a value of \$16,953.8 million by the end of 2027.
