- Market consumption volumes declined with a CAGR of -0.8% between 2017 and 2022, to reach a total of 2,090.3 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.4% for the five-year period 2022 2027, which is expected to drive the market to a value of \$21,427.3 million by the end of 2027.
