- The US Bakery & Cereals market had total revenues of \$137,560.7 million in 2022, representing a compound annual growth rate (CAGR) of 3.8% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.4% between 2017 and 2022, to reach a total of 16,711.4 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.8% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$157,975.1 million by the end of 2027.
