- The Japanese Skincare market had total revenues of \$14,592.8 million in 2022, representing a compound annual growth rate (CAGR) of 1.1% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0% between 2017 and 2022, to reach a total of 1,149.3 million units in 2022.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 1.2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$15,512.3 million by the end of 2027.
