- The breakfast cereals market consists of retail sales of hot cereals and ready-to-eat cereals. Hot cereals segment consists of traditional products (e.g. porridge oats), instant mixes and ready-to-heat products. Ready-to-eat cereals segment consists of children's breakfast cereals and family breakfast cereals such as, flakes, muesli and other RTE cereals. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The Singaporean Breakfast Cereals market had total revenues of \$57.9 million in 2022, representing a compound annual growth rate (CAGR) of 5.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 4.7% between 2017 and 2022, to reach a total of 4.6 million kilograms in 2022.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 5.7% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$76.5 million by the end of 2027.
