- The dairy market consists of retail sales of butter & spreadable fats, cheese, cream, dairy-based & soy-based desserts, drinkable yogurt, milk, soymilk & soy drinks, yogurt and fromage frais & quark. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The Dutch Dairy market had total revenues of \$7,393.1 million in 2022, representing a compound annual growth rate (CAGR) of 4.1% between 2017 and 2022.
- Market consumption volumes declined with a negative CAGR of 0.5% between 2017 and 2022, to reach a total of 1,607 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.4% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$8,755.2million by the end of 2027.
