- The Dutch Cat care market had total revenues of \$993.2 million in 2022, representing a compound annual growth rate (CAGR) of 3.6% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1% between 2017 and 2022, to reach a total of 192.4 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.1% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$1,099.6 million by the end of 2027.
