The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Swiss Skincare market had total revenues of \$484.2 million in 2022, representing a compound annual growth rate (CAGR) of 0.5% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -0.7% between 2017 and 2022, to reach a total of 36.1 million units in 2022.
- The performance of the market is forecast to decline, with an anticipated CAGR of -0.7% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$467.0 million by the end of 2027.
