All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The UK Dairy market had total revenues of \$20,271.1 million in 2022, representing a compound annual growth rate (CAGR) of 4.1% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.4% between 2017 and 2022, to reach a total of 7,595.5 million kilograms in 2022.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 4.1% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$24,812.9million by the end of 2027.
