- The Turkish Savory Snacks market had total revenues of \$1,425.9 million in 2022, representing a compound annual growth rate (CAGR) of 44% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.2% between 2017 and 2022, to reach a total of 227.6 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 34.7% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$6,325.5 million by the end of 2027.
