- Market consumption volume increased with a CAGR of 1.7% between 2017 and 2022, to reach a total of 9,365.5 million units in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.7% for the five-year period 2022 2027, which is expected to drive the market to a value of \$97,467.6 million by the end of 2027.
