- Market consumption volumes declined with a CAGR of -1% between 2017 and 2022, to reach a total of 2,635.6 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.7% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$25,813.6 million by the end of 2027.
