- Within the residential construction industry, China is the leading country among the BRIC nations with market revenues of \$1,941,982.9 million in 2022. This was followed by India, Russia and Brazil with a value of \$206,153.2, \$71,873.2, and \$36,822.1 million, respectively.
- China is expected to lead the residential construction industry in the BRIC nations with a value of \$2,228,298.7 million in 2027, followed by India, Russia, Brazil with expected values of \$297,065.6, \$73,178.1 and \$50,265.6 million, respectively.
