The top 5 emerging countries are expected to reach a value of \$2,643,051.0 million in 2027, with a CAGR of 3.4% over the 2022-27 period.
- Within the residential construction industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,941,982.9 million in 2022. This was followed by India and Mexico with a value of \$206,153.2 and \$44,175.2 million, respectively.
- China is expected to lead the residential construction industry in the top five emerging nations, with a value of \$2,228,298.7 million in 2027, followed by India and Mexico with expected values of \$297,065.6 and \$54,689.9 million, respectively.
