- The global wireless telecommunication services market had total revenues of \$775.4 billion in 2022, representing a compound annual growth rate (CAGR) of 0.6% between 2017 and 2022.
- Market volume increased at a CAGR of 3.2% between 2017 and 2022, reaching a total of 7,517 million subscribers in 2022.
- The growth of the global wireless telecommunication services market can also be attributed to the increase in mobile penetration across the globe. For instance, according to in-house research, mobile penetration in Japan stood at 163.3 per 100 people in 2022.
