- Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the air freight industry and had a total market value of \$19,685.3 million in 2022. Russia was the fastest growing country with a CAGR of -1.3% over the 2018-22 period.
- Within the air freight industry, China is the leading country among the BRIC nations with market revenues of \$14,477.0 million in 2022. This was followed by Russia, Brazil and India with a value of \$3,856.7, \$803.5, and \$548.1 million, respectively.
- China is expected to lead the air freight industry in the BRIC nations with a value of \$16,382.3 million in 2027, followed by Russia, India, Brazil with expected values of \$5,583.2, \$1,465.3 and \$982.4 million, respectively.
