In Lithuania, unlike in neighbouring Latvia, the category has a poor reputation with many consumers avoiding RTDs due to the perceived high sugar level in these drinks. Concerns over rising obesity and diabetes levels alongside the influence of the pandemic have all served to push consumers away from RTDs, which many people also perceive to be full of artificial flavourings and ingredients.
