Overall, retail volume sales of home video are set to continue to decrease strongly over 2023. However, there remains a sharp divergence between the performance of televisions and video players. The strong growth in demand for OLED TVs is offset by the sharp fall in retail volume sales of LCD TVs (largely due to stabilisation after sales spikes during the pandemic), BD players and DVD players.
