There has been a shift away from premium cigarette brands as rising prices have made cigarettes less affordable. Moreover, illicit trade cigarettes outsell retail sales of tax-paid cigarettes in Uganda, with tobacco players asking the government to do more to address this. Despite this, sales of cigarettes saw strong growth in retail volume terms in 2022.
