Wearable electronics is the best performing category in consumer electronics in France in 2023, albeit still in a small volume decline, with this being a notable slump following the positive sales seen in 2022. That said, much of this is attributed to an organic drop in sales following previous spikes in popularity. Also, the current context of inflationary pressures and low consumer spending power means "nice-to-have" devices and "gadgets" are not at the top of many. consumers' priority lists.
