The Canada was the fastest growing country, with a CAGR of 4.2% over the 2018-22 period.
- Within the feminine hygiene industry, the US is the leading country among the NAFTA bloc, with market revenues of \$5,137.9 million in 2022. This was followed by Canada and Mexico, with a value of \$540.4 and \$371.7 million, respectively.
- The US is expected to lead the feminine hygiene industry in the NAFTA bloc, with a value of \$5,951.8 million in 2027, followed by Canada and Mexico with expected values of \$620.9 and \$429.5 million, respectively.
