The breakfast cereals industry within the NAFTA countries had a total market value of \$14,747.2 million in 2022. The Mexico was the fastest growing country, with a CAGR of 6.5% over the 2018-22 period.
- Within the breakfast cereals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$12,042.4 million in 2022. This was followed by Canada and Mexico, with a value of \$1,499.0 and \$1,205.8 million, respectively.
- The US is expected to lead the breakfast cereals industry in the NAFTA bloc, with a value of \$13,582.3 million in 2027, followed by Mexico and Canada with expected values of \$1,663.5 and \$1,603.3 million, respectively.
