The dairy industry within the NAFTA countries had a total market value of \$126,230.5 million in 2022. The US was the fastest growing country, with a CAGR of 7.5% over the 2018-22 period.
- Within the dairy industry, the US is the leading country among the NAFTA bloc, with market revenues of \$99,587.0 million in 2022. This was followed by Mexico and Canada, with a value of \$13,388.9 and \$13,254.6 million, respectively.
- The US is expected to lead the dairy industry in the NAFTA bloc, with a value of \$116,273.1 million in 2027, followed by Mexico and Canada with expected values of \$17,846.5 and \$15,892.1 million, respectively.
