- Within the suncare industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,411.4 million in 2022. This was followed by Brazil and Mexico with a value of \$526.4 and \$103.4 million, respectively.
- China is expected to lead the suncare industry in the top five emerging nations, with a value of \$1,773.5 million in 2027, followed by Brazil and Mexico with expected values of \$674.7 and \$131.9 million, respectively.
