- The ice cream market consists of artisanal ice cream (both dairy and water-based), impulse ice cream (includes single-serve ice cream tubs, packaged cones ice cream sandwiches, and chocolate-coated ice creams) and take-home ice cream (includes multiple-serving ice cream tubs and, ice-cream cakes). The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The South African Ice Cream market had total revenues of \$400.3 million in 2022, representing a compound annual growth rate (CAGR) of 7.2% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 3.4% between 2017 and 2022, to reach a total of 65.9 million kilograms in 2022.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 7.2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$565.8 million by the end of 2027.
