Moreover, the sugar confectionery products consists of hard boiled sweets, mints, caramels & toffees, gums and jellies, marshmallows, fudges and medicated throat lozenges. The market is valued according to retail selling price (RSP) and includes any applicable taxes. Any currency conversions used in the creation of this report have been calculated using constant 2022 annual average exchange rates.
- The South African Confectionery market had total revenues of \$1,699.3 million in 2022, representing a compound annual growth rate (CAGR) of 5.9% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2% between 2017 and 2022, to reach a total of 119 million kilograms in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 6.2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$2,300.8 million by the end of 2027.
