- The Singaporean internet access market had total revenues of \$0.4 billion in 2022, representing a compound annual growth rate (CAGR) of 0.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.3% between 2017 and 2022, to reach a total of 0.004 billion Internet Users in 2022.
- Singapore accounted for 0.2% in the Asia-Pacific internet access market in 2022. Continuous adoption of technology both by individuals and major industries is driving the market.
