- The jewelry & watches segment was the market's most lucrative in 2021, with total revenues of \$6,723.7 million, equivalent to 59% of the market's overall value.
- In Germany, travel restrictions, lockdown measures, and ban on exports has led to market decline in 2020. In 2021, demand growth in luxury goods led to recovery in the market.
