- The Internet access market includes all Internet service revenues collected to provide narrowband and broadband Internet access through consumer and business channels. All revenues calculated are retail revenues that are exclusive of taxes. Only fixed communication is included, and mobile phone connections are not considered.
- The Dutch internet access market had total revenues of \$2.3 billion in 2022, representing a compound annual growth rate (CAGR) of 2.6% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.8% between 2017 and 2022, to reach a total of 0.01 billion Internet Users in 2022.
- The Netherlands accounted for 3.2% in the European internet access market in 2022. The rate of household and mobile broadband penetration throughout the continent serves as evidence that Europe is one of the most connected continents in the world.
