- The Spanish Feminine Hygiene market had total revenues of \$726.7 million in 2022, representing a compound annual growth rate (CAGR) of 0.9% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -0.4% between 2017 and 2022, to reach a total of 174.8 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$801.7 million by the end of 2027.
