#### Key Highlights

- The Jewelry, Watches and Accessories market includes gold jewelry, silver jewelry and other precious jewelry like diamonds, platinum, precious stones (sapphires, emeralds and rubies), pearls (natural and cultured) and semi-precious stones (e.g. quartz, opal, topaz, amethyst, coral etc.), fashion jewelry (non-precious jewelry), hair accessories, belts, hats, gloves, scarves, sunglasses and ties, plus watches.
- The UK jewelry & watches market is forecast to generate total revenues of \$14,158.0 million in 2021, representing a compound annual rate of change (CARC) of -2.2% between 2017 and 2021.
- The jewelry & watches segment was the market's most lucrative in 2021, with total revenues of \$8,611.1 million, equivalent to 60.8% of the market's overall value.
- In 2020, the market declined due to lack of demand in the country. This is attributed to low consumer spending on luxury goods as people stayed at home and lack of tourism. However, the market record strong growth in 2021 owing to opening of pent-up demand associated with wedding and events, economic recovery in the country, and improvement in consumer confidence.
