- Market consumption volume increased with a CAGR of 3% between 2017 and 2022, to reach a total of 0.6 billion Internet Users in 2022.
- The UK accounted for 21.1% in the European internet access market in 2022. The rate of household and mobile broadband penetration throughout the continent serves as evidence that Europe is one of the most connected continents in the world. Continuous adoption of technology both by individuals and major industries is driving the market.
