The top 5 emerging countries are expected to reach a value of \$210,704.1 million in 2027, with a CAGR of 8.6% over the 2022-27 period.
- Within the generics industry, China is the leading country among the top 5 emerging nations, with market revenues of \$111,666.9 million in 2022. This was followed by India and Mexico with a value of \$17,617.5 and \$6,036.8 million, respectively.
- China is expected to lead the generics industry in the top five emerging nations, with a value of \$171,144.4 million in 2027, followed by India and Mexico with expected values of \$26,308.6 and \$7,402.3 million, respectively.
