The airlines industry within the NAFTA countries had a total market value of \$253,573.7 million in 2022. The Mexico was the fastest growing country, with a CAGR of -4.6% over the 2018-22 period.
- Within the airlines industry, the US is the leading country among the NAFTA bloc, with market revenues of \$232,450.9 million in 2022. This was followed by Canada and Mexico, with a value of \$11,788.3 and \$9,334.5 million, respectively.
- The US is expected to lead the airlines industry in the NAFTA bloc, with a value of \$401,701.3 million in 2027, followed by Canada and Mexico with expected values of \$27,385.9 and \$18,367.3 million, respectively.
