- Within the tobacco & tobacco products industry, China is the leading country among the top 5 emerging nations, with market revenues of \$389,395.7 million in 2022. This was followed by India and Mexico with a value of \$19,297.6 and \$5,897.3 million, respectively.
- China is expected to lead the tobacco & tobacco products industry in the top five emerging nations, with a value of \$413,385.4 million in 2027, followed by India and Mexico with expected values of \$22,508.8 and \$6,562.5 million, respectively.
