The volume of people travelling by air more than doubled in 2023, supported by the relaxation of border control measures, both within Taiwan and neighbouring Asian countries. With air travel having been off-limits during the pandemic, there was a release of pent-up demand from both business and leisure customers. National carrier Eva Airways, for example, reported a load factor in excess of 80% during the first quarter of the year, despite rising ticket prices, due to the increased cost of fuel.
