- Market consumption volumes grew with a CAGR of 1.8% between 2017 and 2022, to reach a total of 125.9 million total subscriptions in 2022.
- Egypt's share in the Middle East telecommunication services market stood at 19.8% in 2022. The growth in 2022 is attributed to the growing proportion of internet users and the increasing mobile subscriber penetration rate.
