- The military aircraft segment accounted for market's the largest proportion in 2022, with total revenues of \$0.4 billion, equivalent to 39.6% of the market's overall value.
- According to in-house research, the total budget for the Ministry of National Defense (SEDENA), which is responsible for the air force and army, and the Secretariat of the Navy (SEMAR) is \$6.9 billion in 2022. This figure is forecast to rise to \$8.8 billion in 2027, a positive CAGR of 5.5%.
