- The US Oils & Fats market had total revenues of \$8,624.0 million in 2022, representing a compound annual growth rate (CAGR) of 3.6% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2% between 2017 and 2022, to reach a total of 1,968.5 million kilograms in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.8% for the five-year period 2022 2027, which is expected to drive the market to a value of \$10,380.2 million by the end of 2027.
