- Market consumption volume increased with a CAGR of 0.5% between 2017 and 2022, to reach a total of 1,065.9 million kilograms in 2022.

- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.4% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$6,622.4 million by the end of 2027.
