- The Hong Kongese telecommunication services market had total revenues of \$5.79 billion in 2022, representing a compound annual growth rate (CAGR) of 1.9% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 3.2% between 2017 and 2022, reaching a total of 27 million total subscriptions in 2022.
- Hong Kong's share of the telecommunication services market in Asia-Pacific stood at 0.8% in 2022. The growth in 2022 is attributed to the growing proportion of internet users and the increasing mobile subscriber penetration rate.
